Introduction

Purpose and Scope

The *Product Overview* part of this document presents an overview of AT&T UNIX System V/386 and describes the basic structure and benefits of the UNIX operating system. It is divided into the following chapters:

- Chapter 1, "Introduction," presents an overview of AT&T UNIX System V/386.
- Chapter 2, "Key Elements of the UNIX System," presents an overview of the UNIX System describing the structure and components that comprise the operating system. It also describes the benefits a user may realize from using the UNIX System.
- Chapter 3, "Features of AT&T UNIX System V/386 Release 3.2," describes the features and documentation unique to AT&T UNIX System V/386 Release 3.2.
- Glossary, contains a list of terms and their definitions as used in this document.

Audience

The audience for this document includes current and potential users of AT&T UNIX System V/386 Release 3.2.

Important terms are explained as they are introduced. For a description of terms not explained in text, see the Glossary. Most features are described in general terms. Some features are aimed at a more technical audience and may require an understanding of concepts in communications, networking, or programming for which explanations are beyond the scope of this document.

Introduction

Overview

AT&T UNIX System V/386 Release 3.2, jointly developed by AT&T and MICROSOFT, incorporates XENIX System V compatibility into the advanced technology of AT&T UNIX System V. This provides a standard, multi-tasking, multi-user operating system for INTEL 80386-based machines.

This release supports the MICROSOFT XENIX application programming interface (with system call extensions supporting existing XENIX System V/386 and XENIX System V/286 applications) at both a source code and binary executable level. The product inherits XENIX System V floating point emulation and provides extensions supporting XENIX semaphores, messages, shared data inode types, and mountable file systems.

The system fully conforms to the System V Interface Definition and is compatible with all previous releases of AT&T UNIX System V on the INTEL 80386 at a source, binary executable, and object code level. AT&T UNIX System V/386 Release 3.2 also provides emulation routines supporting AT&T UNIX System V/286 Release 2 binary executables.

The system provides improved performance through the use of enhanced memory mechanisms, broader support for floating point co-processors, and an optional 2-kilobyte file system utility employing a larger block size to improve disk throughput.

This release incorporates shared memory enhancements, a STREAMS based pseudo-terminal subsystem, software terminal control, hardware terminal emulation, and signal mechanism enhancements supporting the X Window System Version 11 Release 2 developed by Massachusetts Institute of Technology. It is fully compatible with VP/ix, enabling the system to simultaneously run multiple MS-DOS applications. Other improvements provided with this release include enhanced LP spooler, Extended Terminal Interface (ETI), automated software setup, and enhanced security features.

AT&T UNIX System V Release 3.2 preserves the software investments of end users and provides them with the opportunity to select from thousands of existing UNIX System and XENIX system applications. It also establishes a standard applications binary interface for the INTEL 80386 machine that will enable independent software vendors to concentrate their efforts on the development of new software products. **Key Elements and Benefits**

Key Elements of the UNIX System

The UNIX System includes the following key elements:

- UNIX operating system kernel
- shell command interpreter and programming language
- UNIX file system
- various user and system commands.

The kernel, shell, and file system are discussed in more detail in the following sections.

Kernel

The UNIX operating system kernel (comprising from 5 to 10 percent of the software provided with the system) is the basic resident software on which the entire system relies. It is the only part of the system that permanently resides in memory. The kernel controls user processes and manages system resources.

The kernel executes the shell, overseeing the execution of user programs (or commands) while controlling access to the file system. These programs seem to execute simultaneously because of the system's ability to share the processor among all the programs. Actually, each program is scheduled to use the processor for a short period of time to the exclusion of all other programs. The capability to run several programs simultaneously is called multi-tasking.

The kernel, using this multi-tasking capability, provides a multi-user capability that lets many people use the system simultaneously. In addition, each of these users can be running several programs at once.

Shell

The shell command interpreter allows the user to communicate with the UNIX System. Besides providing the user interface to the kernel and interpreting operating system commands, the shell can be used as a programming language. The user can quickly and easily write custom "shell scripts" to do simple or complex tasks. The shell allows users to enhance and build on UNIX System capabilities and to adapt the operating system to many user applications without using a compiler or link editor.

File System

The UNIX file system consists of a set of directories and files arranged in a tree-like structure. The file system is built up in a hierarchical way from the root (/) directory, which contains certain standard subdirectories, including **bin**, **dev**, **etc**, **install**, **lib**, **lost+found**, **mnt**, **tmp**, and **usr**. These standard subdirectories are required for the system to operate properly. The root directory may contain other directories, including those that users structure to suit their needs.

Features of the UNIX file system include the following:

- Simple and consistent naming conventions. You can create and reference file and directory names using the same conventions. You can also refer to files and directories with either a full path name (for example, /usr/bin/program1) or with a path name (for example, bin/program1) relative to the current directory in which a user is working (for example, /usr). This convention lets users access logically related files quickly.
- Automatic file space allocation and deallocation that is invisible to the user.
- Facilities for creating, accessing, copying, moving, and processing files, directories, or sets of these in a simple, uniform, and natural way.
- Flexible directory and file protection modes that allow all combinations of read, write, and execute permissions. You can control these access modes independently for the owner of each file or directory, for a group of users (such as all members of a project), and for all other users. The file protection modes are set automatically when a file is created but can be changed from the shell or under program control by the owner of the file.
- Facilities for locking files or records within files. This capability is especially useful for programs that read or update data bases.
- Transparent file sharing among computers. Each computer on a network has control over what local resources other computers can access and what remote resources its users can access.
- Input/output (I/O) routines that treat each physical I/O device the same; from interactive terminals to main memory. This allows uniform file and device input and output.

- Mountable and unmountable file systems and volumes, which allow users easy access to additional disk space.
- File linking across directories of the same file system. This capability allows one file to "logically" exist in several directories without actually existing as multiple copies.

Benefits of the UNIX System

This section describes how the UNIX System differs from most operating systems.

The job of an operating system is to allocate the resources of the computer. Some operating systems process only one request at a time, thereby restricting the resources of the computer to one user (or one task or process) at a time. The UNIX System allows many processes to run simultaneously. For example, it can be sending output to several printers, running a spreadsheet program, updating a data base, sending electronic mail to another computer, and accepting input from several terminals – all at the same time. This is known as multi-tasking. This multi-tasking capability also allows many users to simultaneously interact with the system. This is called multi-user mode. Each user can have several processes running simultaneously.

The design of the UNIX System makes it easy to manipulate files and the input and output of commands. The hierarchical file system structure permits easy addition, deletion, and movement of files within a structure set up by the user. Commands can take input from either a terminal or a file, and direct output to a file or to a peripheral device, as well as to the terminal. In addition, the output of one command can be directed (piped) to be the input of another command, so users can easily build their own specialized functions.

The basic user interface of the UNIX System (the shell) is a command interpreter that recognizes and interprets commands entered by the user. The shell is also a programming language that can be used to create custom applications and functions.

Some operating systems only offer some of these features, but the UNIX System offers them all. These benefits are organized under the topics of power, portability, compatibility, flexibility, and standardization.

Power

The following list summarizes the powerful features of the UNIX System:

- The UNIX System is multi-tasking; this capability enables many tasks to be accomplished simultaneously.
- The UNIX System is a multi-user system; this capability enables many users to accomplish their work simultaneously, as well as share programs and data.

- Each user can run several tasks simultaneously.
- The UNIX System is designed so that applications can be added to it easily and without modification to the source code. Examples of this include the addition of new devices (such as terminals, printers, and plotters) and new communications protocols.
- Files can be shared transparently among computers, yet access can be carefully controlled by system administrators.

Portability

The following list summarizes the portability of the UNIX System:

- The UNIX System runs on computers ranging from microcomputers to mainframes because it can be changed to work on new computer hardware more easily than other operating systems. This portability is possible because most of the operating system is written in the highlevel C language (developed at AT&T Bell Laboratories).
- The UNIX System environment is portable. Once you have learned to use the UNIX System, you can use different computer hardware that runs the UNIX System without having to relearn the basics of the system. The applications software, training, documentation, and your knowledge and expertise with the UNIX System can be applied immediately to make you productive on your new hardware.
- The combination of commands, languages, and program libraries makes it easy to develop and maintain new application programs or systems of programs. (Examples include text processing and data base management systems, and applications for medical suppliers, retailers, and other markets.) Once these applications are developed, they are easily ported to new versions of the UNIX System, or to UNIX Systems running on a variety of computer hardware.
- The Extended Terminal Interface (ETI) and curses/terminfo utilities allow user programs to produce output on many different types of terminals. This portability provides the programmer with features such as window control, highlighting, scrolling, access to special keys, color, and menus. These utilities work with a data base that describes the

hardware features and control sequences used by different terminals. Thus, the programmer can write terminal-independent applications that use the terminal-dependent specifications found in a common data base.

Compatibility

The following list summarizes the compatibility features of the UNIX system:

- Source code written to run on a given release of the UNIX System is generally compatible across many computer systems. (See the section "Standardization" for a description of efforts to broaden source-code compatibility.)
- AT&T UNIX System V/386 Release 3.2 combines the essential elements of AT&T UNIX System V and XENIX System V to enable end users to use the full range of AT&T UNIX System V and XENIX System V applications written for INTEL 80286- and 80386-based machines.
- When a new release of the UNIX System is issued, every effort is made to ensure that object code for application products continues to work on the new software release.

Flexibility

The following list summarizes the flexibility of the UNIX System:

- The shell command language lets you tailor the user interface to meet specific needs; each user can have a different interface.
- The UNIX System treats all files alike, unlike other systems that have many types of files. This means users access files identically from any program or command.
- A practical (hierarchical) file system structure simplifies file organization and access.
- I/O routines treat each physical I/O device the same, from interactive terminals to main memory. This feature allows uniform file and device input and output.

Standardization

The following list summarizes the efforts that AT&T is making to standardize the UNIX System:

- AT&T is participating with other vendors in industry standard groups such as /usr/group, American National Standards Institute (ANSI) X3J11, and Institute of Electrical and Electronic Engineering (IEEE). The IEEE P1003 working group has developed a standard for the portable operating system environment, "POSIX". AT&T UNIX System V/386 Release 3.2 fully conforms to the POSIX standard, as well as all subsequent releases of AT&T UNIX System V. AT&T UNIX System V conforms to the System V Interface Definition (SVID) Issue 2. SVID is a standard for system and subroutine calls and for defining a base system and extensions. These standards will make it easier to develop applications that can be run on many different computers that run the UNIX System.
- The UNIX System supports a Transport Interface based on the the Transport Service Definition (Level 4) of the International Standards Organization (ISO) Reference Model for Open Systems Interconnection (OSI). This interface defines how to access the services of a transport protocol. (For more information, see Chapter 3, "Features of AT&T UNIX System V/386 Release 3.2".)

Features of AT&T UNIX System V/386 Release 3.2

This chapter describes the features of AT&T UNIX System V/386 Release 3.2.

XENIX System V Compatibility

AT&T UNIX System V/386 Release 3.2 provides full binary and source code compatibility with applications developed for Microsoft XENIX System V/386, Microsoft XENIX System V/286, AT&T UNIX System V/386, and AT&T UNIX System V/286. The following list describes the level of XENIX System V support:

- Source code written for Microsoft XENIX System V/386 programs and applications can be compiled and linked on AT&T UNIX System V/386 without having to modify the source code.
- Binary executables developed for Microsoft XENIX System V/386 and Microsoft XENIX System V/286 (Release 2.0 and later) can be run on AT&T UNIX System V/386 without having to recompile the applications.
- The structure of the AT&T UNIX System V/386 filesystem allows both Microsoft XENIX System V and AT&T UNIX System V binary applications to be executed. It also supports the mounting of a XENIX removable filesystem.
- Support for XENIX system call extensions enables programs to run as they did under the XENIX system.
- All device driver support routines available under Microsoft XENIX System V/386 are available in AT&T UNIX System V/386.

In addition to the program interface, several Microsoft XENIX System V commands have been added for ease of use and compatibility. Tools are provided that allow the installation of all existing UNIX System and XENIX system packages.

Enhanced Line Printer Spooling Utilities

The Line Printer Spooling Utilities have been expanded to offer easy access to forms (for example, pre-printed invoices and payroll checks) and easier administration of filters.

Enhanced Security Features

UNIX System security features were further enhanced through the addition of features that display the last login time, maintain a log of unsuccessful login attempts, restrict removal of files from public directories, and restrict access to passwords.

Hardware Floating-Point Support

AT&T UNIX System V/386 supports floating-point calculations through the INTEL 80287 and 80387 numeric co-processors or the WEITEK 1167 chip set. In the absence of a co-processor, AT&T UNIX System V/386 provides floating-point emulation.

Remote File Sharing

The Remote File Sharing (RFS) feature lets you share files, directories, devices, and named pipes among computers that are linked by a network. The administrator of each computer on the network controls which local resources are available to other computers and which remote resources local users can access.

Sharing is done at the directory level. When you share a directory, you share its entire contents: files, subdirectories, named pipes, and special devices (such as printers and typesetters). With RFS, you can share data files with other departments, a letter-quality printer or typesetter, and more.

Since RFS is designed to be media- and protocol-independent, you can share files transparently across a wide variety of computer systems and networks that use AT&T UNIX System V and conform to the AT&T Transport Interface.

STREAMS Mechanism and Tools

STREAMS is a general, flexible facility and a set of tools for development of communication and networking services within the UNIX System. STREAMS provides a uniform mechanism for program development, ranging from networking applications to individual device drivers.

STREAMS defines standard interfaces for character I/O within the UNIX System kernel, and between the kernel and the rest of the UNIX System. This standard interface and mechanism enables modular, portable program development and easy integration of network services. These interfaces have been used in the development of protocol modules and device drivers since Release 3.0. STREAMS provides a broad framework that does not impose any specific network architecture. Its user interface is consistent and compatible with the existing character I/O mechanism, so both STREAMS and character I/O mechanisms are available to the programmer. This modularity allows the following functionality:

- User-level programs (commands such as uucp) can be independent of underlying protocols and communications media, so the programs need not be changed when new media or protocols between systems become available.
- Network architectures and higher-level protocols can be independent of underlying protocols, drivers, and media.
- Higher-level services can be created by selecting and connecting lowerlevel services and protocols.

In addition to the standard interfaces, STREAMS provides a set of software tools that help you build modules and drivers.

AT&T Transport Interface

The AT&T Transport Interface supports two modes of transfer. The first mode is circuit-oriented and transports data over an established connection in a reliable, sequenced manner. The second mode is message-oriented and supports data transfer in self-contained units with no logical relationship required among units.

Features of AT&T UNIX System V/386 Release 3.2

The AT&T Transport Interface defines how a user accesses the services of a transport protocol. The protocol module is called a Transport Provider.

Applications programs access the Transport Provider by using the Transport Interface routines in the new Network Services Library. These routines support access to a Transport Provider in a media- and protocolindependent manner. The Transport Provider uses kernel-level routines to send the information to the desired physical device. By using the AT&T Transport Interface, applications programs can access other Transport Providers that may be available in the future.

Two applications that currently use the Transport Interface are Remote File Sharing and the **uucp** command. Remote File Sharing is implemented in the kernel, so it accesses the STREAMS-based Transport Provider protocol modules directly. The **uucp** command, which is an application program, calls routines in the Network Services Library. In turn, these routines access the Transport Provider.

Media-Independent uucp

AT&T UNIX System V/386 provides queued file transfer services to other UNIX Systems by direct-connect and dial-up methods. In addition, **uucp** has been enhanced to work with networks that are compatible with the AT&T Transport Interface, permitting **uucp** to send files to other systems over any Transport Provider that conforms to this interface.

STREAMS-based modules have been provided so that remote login services via **cu** can also be used over a network.

Other new capabilities include the ability to define (within a **Sysfiles** file) different or multiple **Systems**, **Devices**, and **Dialers** files, and the ability to define (within a **Devconfig** file) STREAMS-based transport providers for **cu** and **uucp** services.

At installation, you can indicate which, if any, Transport Providers are available. If new Transport Providers become available, no changes are needed to the software to accommodate the underlying media or protocols.

Listener

For each Transport Provider on a system, there is an active user-level program called a Listener. The purpose of the Listener is to receive requests for network services from another system, interpret which network service is needed, and initiate a process that has been designated to provide the requested network service. The Listener then drops out of the communications path and continues to listen for new service requests.

Shared Libraries

A Shared Library is a library of routines that is accessed dynamically at runtime rather than having those routines combined with an application program at load time. End users of shared libraries benefit in several ways:

- The application program may occupy less space on the disk.
- When routines in a shared library are changed, the new, improved versions are accessible without recompilation of the programs that access them. For example, by improving the performance of one routine, the performance of every application that uses that routine is immediately improved.

A shared library that contains most commonly used routines from the C Library is part of all AT&T UNIX System V/386 systems. Most UNIX System commands use routines from this library, along with any applications that were built with them. When you use commands and applications created using shared libraries, these routines are accessed without any special action on your part.

Shared Libraries Generation

AT&T UNIX System V/386 provides utilities that enable a programmer to build a library of routines that is accessed dynamically at runtime, rather than having those routines combined with an application program at load time. The end user of the application can benefit in several ways (see the previous section, "Shared Libraries").

Command Syntax Standard

A new shell command, **getopts** (an enhanced version of the **getopt** command), is consistent with and supports the applicable rules (Rules 3-10) of the UNIX System command syntax standard. [The standard is described in the *intro*(1) manual page of the *User's/System Administrator's Reference Manual*.] Use of the **getopts** command in place of the **getopt** command is strongly encouraged because the **getopt** command will no longer be supported with the next major release of the UNIX System. To assist in the conversion of affected shell scripts, a conversion command, **getoptcvt**, is provided.

Signal Mechanism Enhancements

A new set of system calls provides an improved mechanism to manage signals. These new calls allow a programmer to establish critical sections of code that will not be interrupted by a set of signals. These signals are not discarded, but are held until released at the end of the critical section. These signal-handling system calls are compatible in name and calling sequences with the BSD 4.1 (Berkeley) version of the UNIX System.

Improved Terminal Support Facilities

There are three improved facilities for supporting terminals:

Remote Terminal Support

The Remote Terminal Support (often called **curses/terminfo)** provided with the AT&T UNIX System V/386 has the following new features:

- Support for filters, soft labels, and new AT&T terminals and printers: 510, 513, 4410/5410, 4425/5425, 605, 610, 615, 620, and 630.
- New commands: **captoinfo** converts **termcap** entries to **terminfo** entries, and **infocmp** compares two **terminfo** entries or prints entries in several formats. For example,

infocmp –I termtype

prints out the description of the terminal *termtype* from the **terminfo** data base.

- New options to the **tput** command to initialize and reset a terminal.
- A version of the **terminfo** compiler, **tic**, that is from 50 to 100 times faster than the previous version and does much better error checking.

Terminal Windowing Utilities

AT&T UNIX System V/386 provides the basic software commonly required by AT&T windowing terminals such as the AT&T 630 terminal. Routines included perform the following functions: create, delete, and manipulate terminal windows, query terminal window status, and provide statistics about usage of windowing routines.

Extended Terminal Interface (ETI) Utilities

High-level C language subroutine libraries built on **curses/terminfo** provide enhanced character mode screen management functions, color/curses enhancements, and menus. The Extended Terminal Interface also provides a TAM transition library enabling character-based, multi-user applications written to the UNIX PC to be ported with minimal modification.

Crash Command Changes

In addition to providing debugging support for the new operating system features, the user interface to the **crash** command has been changed extensively for ease of use. The syntax of all the functions has been standardized so that similar functions share similar syntax. **crash** has a **help** function, a number base converter, a memory search function, and a disassembler capability.

New Header Files and Definitions

The following three header files and definitions were added to **/usr/include**:

unistd.h contains definitions for symbolic constants introduced and used throughout the 1984 /usr/group Standard publication

- **limits.h** contains definitions for commonly used values that vary for different implementations of the UNIX System
- **sys/stat.h** contains new definitions to make it easier for programmers to write portable code.

Internationalization

The following features are for customers writing application software for use in an international environment:

Support for 8-bit Code Sets

The **cat**, **ed**, **egrep**, **expr**, **find**, **grep**, **ls**, **pg**, **sed**, **sort**, and **vi** commands and the **curses** library were changed to properly handle code sets that use all 8 bits. Because ASCII uses only 7 of the 8 available bits in a byte, some commands made special use of this eighth bit; other commands assumed that if the bit was set, the byte was invalid. Other commonly used commands, such as **sh** (the shell), already supported 8-bit code sets. In addition, 8-bit characters can be sent between a terminal and the system.

Support for Alternate Date and Time Formats

The **cpio**, **date**, **ls**, **mount**, **pr**, and **sort** commands were changed to provide the date and time in the language and format specified by the **LANGUAGE** environment variable. While the United States conventions remain the default, other languages can be supported by creating and installing a file for the language desired in the /lib/cftime directory. The contents of that file include:

- month and day (full and abbreviated)
- default local time and date formats
- default output of the **date** command if the **CPTIME** environment variable is not set.

In addition, time zones and alternate time zones (such as daylight time) now can be defined in terms of hours and minutes using the **TZ** environment variable.

Support for Alternate Character Classification and Conversion Rules

The **cat**, **ed**, **egrep**, **grep**, **ls**, **pg**, **sed**, **sort**, and **vi** commands (commands that convert characters from uppercase to lowercase or classify characters as alphabetic, printable, uppercase or lowercase, etc.) were changed to support code sets or classification rules according to the value of the **CHRCLASS** environment variable. While ASCII remains the default for these operations, other conversion and classification rules can be supported by creating and installing a file describing these rules in the **/lib/chrclass** directory. A new administrative command, **chrtbl**, is used to create this file.

New awk (nawk)

awk is a programming language for information retrieval and data manipulation that is often used by people who have no programming background. **nawk** includes the following features:

- ability to define functions
- new keywords: delete, do, func, function, return
- new built-in functions: atan2, cos, sin, rand, srand, gsub, sub, match, close, and system
- new pre-defined variables: FNR, ARGC, ARGV, RSTART, and RLENGTH
- input field separator variable, FS, and the third argument to split are treated as regular expressions
- precedence of operations to match C language precedence.

Because some of these enhancements may not be compatible with some existing **awk** programs, you will get the old version when you type **awk**. To take advantage of these new features, you must use the **nawk** command.

Performance Improvements

Performance has been improved in several key areas:

Kernel Size

The Release 3.2 kernel allows the combination of text and data sections of the kernel to grow to a size greater than that of the Release 3.1 and 3.0 restriction [base memory (usually 640K) minus the size of the boot loader (about 40K)].

Note that there never has been, and still is not, a limit on the total kernel size (text + data + bss).

Enhanced Memory Management

Enhanced memory management for lower process overhead and greater system throughput is provided.

Paged User Area

The user area for each process can now be paged like the rest of each process. This enhancement significantly improves the performance of limited-memory systems by making more memory available.

Demand Paging

Demand paging, a memory-management technique, enables the system to divide the memory space of a process into small, fixed-size units, which are swapped in and out of main memory only as needed. With demand paging, a process size may exceed the system's available memory space. Demand paging can also improve performance when many users are simultaneously using the system.

2-Kilobyte File System Utility

The 2-Kilobyte File System Utility provides an optional method of file system organization. This method employs 2-Kilobyte block sizes to improve disk I/O performance with applications that use a file system with an unusually high proportion of large files.

Remote File Sharing Client Caching

This feature enables a client system (one that is accessing data from another system) in a Remote File Sharing (RFS) arrangement to maintain a local copy of the data it needs. This means that when a block of data is read from or written to a remote system, it is placed in a local buffer where it can be accessed by subsequent requests for data by local processes. This method can significantly reduce the amount of data that needs to be sent across the network, resulting in significant performance improvements for many patterns of remote file use. For example, applications that access data from a small set of files, such as data base systems, will benefit from this feature.

Mechanisms are built into the client-caching feature to ensure file consistency across the network when multiple machines have opened a file and when a process reopens a previously closed cached file.

By default, client caching is enabled; however, caching can be turned off for a particular resource or for an entire system.

Improved Recovery of Files from cpio Archives

If users encounter errors while restoring a file from floppy disk using **cpio**, they can now skip over the bad blocks and continue restoring with the next file.

Additional Features

Additional features of UNIX System V/386 include:

Remote File Sharing Loop Back

Loop back, also called self-mount, enables users to simulate the higher levels of Remote File Sharing (RFS) functionality on a single system. Application programs designed to use RFS can be partially tested and demonstrated without actually communicating with a remote computer.

Incremental Backup of Nested File Systems

A procedure has been implemented to permit incremental backup of nested file systems. (/a1 is a file system; a1/bl is a nested file system.)

Mandatory File and Record Locking

This feature permits a process to lock a file or records within a file for exclusive use. This is especially useful for programs that read or update data bases.

Installable Device Drivers/Tunable Parameters

AT&T UNIX System V/386 provides an automatic installable driver mechanism that permits a user to reconfigure a system with additional device drivers. A user may also modify system parameters to optimize performance in various configurations.

Software Packaging

AT&T UNIX System V/386 Release 3.2 Foundation Set and User Interface Utilities

This product consists of the standard UNIX System V/386 Release 3.2 Foundation Set and additional AT&T utilities supporting the user interface.

The Foundation Set is the UNIX System V/386 Release 3.2 application binary interface standard. It provides the operating system kernel and a basic set of utilities. The Foundation Set is divided into the following eight distinct packages:

- Base System Package
- Editing Package
- Remote Terminal Package
- Security Administration Package
- XENIX File System Utility Package
- 2-Kilobyte File System Utility Package
- Network Support Utilities Package
- Remote File Sharing Package

In addition, the Foundation Set provides the following additional packages supporting the user interface.

- FMLI Package
- FACE Package
- FACE HELP Package

Software Packaging

Foundation Set Package Description

Base System Package: The Base System Package is the minimal required UNIX System V/386 Release 3.2 runtime system. All other packages need never be installed if the utilities they provide are not required by the user or by an application the user intends to install. The Base System Package consists of the following utilities:

- Essential utilities providing the operating system kernel, base system device drivers, and ninety of the most essential UNIX System utilities.
- XENIX system commands and system headers added by Microsoft Corporation in support of compatibility features.
- System administration utilities providing the commands for managing the hardware and software resources used on the system.
- Basic networking utilities providing the uucp queued file transfer services.
- Enhanced lineprinter spooler utilities enabling printer sharing through the temporary storage of data and queuing of print request.
- Tunable parameters which enable the system to be modified for maximum performance under various hardware configurations and system load conditions.
- Installable drivers which enable the system to incorporate additional device drivers.
- Interprocess communications utilities permitting cooperating processes to share data and communicate with each other.
- User environment utilities providing the commands used to perform mathematical calculations, check or change the executing environment, schedule commands to be run at a later time, and permit interaction with more than one shell layer or switch between layers.
- Process accounting utilities, terminal filters, and the termcap database.

Editing Package: The Editing Package is optionally installable and consists of the following:

- Advanced editing utilities such as the "vi" screen editor.
- Directory and file management utilities permitting comparison and manipulation of the contents of files and directories.
- Spell utilities that enable checking for misspelled words in a file.

Remote Terminal Package: The Remote Terminal Package is optionally installable and consists of the terminfo database containing the descriptions and operating capabilities of the AT&T 600 series terminals as well as over 150 ANSI 3.64 and curses compatible terminal devices.

Security Administration Package: The Security Administration Package is optionally installable and consists of encryption and decryption algorithms for encoding and decoding sensitive data files.

NOTE

The Security Administration Package is delivered in a separate shrink-wrapped package and is distributed only to domestic customer sites in accordance with government export restrictions.

XENIX File System Utility Package: The XENIX File System Utility Package is optionally installable and provides a mechanism for supporting mountable XENIX file systems. Installation of this package is not required for XENIX application binary compatibility.

2-Kilobyte File System Utility Package: The 2-Kilobyte File System Utility Package is optionally installable and provides alternative method of file system organization employing a larger block size (2K) to improve disk throughput performance. This package is recommended for network server applications.

Network Support Utilities Package: The Network Support Utilities Package is optionally installable and provides the STREAMS and system network extensions supporting applications such as Remote File Sharing and the AT&T XWINGraphical Windowing System with the AT&T OPEN LOOK[™] Window Manager. **Remote File Sharing Package:** The Remote File Sharing Package is optionally installable and provides the facilities needed to share files transparently across a network.

AT&T User Interface Utilities Packages

FMLI Package: The FMLI Package is optionally installable and provides the forms and menu language interpreter supporting FACE as well as any other similarly developed interface that a user may wish to install in addition to or in substitution for FACE.

FACE Package: The FACE Package consists of the AT&T developed user interface and the virtual terminal layer manager. Introduction

This Documentation Roadmap section will help you identify documents associated with your AT&T UNIX System V/386 Release 3.2. It also identifies separately purchased but related documents that will enhance usage and understanding of the UNIX System. The AT&T UNIX System V/386 Release 3.2 consists of the software, documentation, as defined in the AT&T UNIX System V/386 Release 3.2 Product Overview.

Most people will use the Roadmap in one of the following ways:

- to understand general relationships among the documents
- to identify the documents they need to do a particular task
- to learn about additional documents that might be of interest
- to learn how to order documents.

The *Roadmap* contains a variety of information. It describes the different types of documents available to you. It shows, in a series of diagrams, the relationships among the different documents you need to do various tasks. For each document, it specifies the intended audience and any prerequisite documents or knowledge, and gives a summary of the contents.

What's in the Rest of the Roadmap

The remainder of this chapter describes the different types of documents available—guides, reference manuals, manuals, product overviews, and release notes—and conventions used for document titles.

Chapter 5, Aids for Identifying Documents, is where you'll find the "maps." A series of diagrams, arranged much like a flowchart, starts with a high-level view of the six major categories of topics. Pointers from that map direct you to others, and each step brings you closer to identifying the document you need while showing you how the documents are related to one another. There's also an alphabetical index. It's useful when you have a specific topic already in mind. It directs you to Chapter 6, where the documents you need are described in greater detail.

Chapter 6, Document Descriptions, is organized alphabetically by document title. For each document it gives: the document title, the name of the product described, any prerequisite documents or knowledge, the intended audience, the document ID number (the number you use to order the document), and a summary of the document's contents.

The Glossary defines UNIX System and computer industry terms that are used in this document although most terms you must know are explained as they are introduced in the text.

What's in the Documents

The titles of the documents follow conventions intended to help you tell, from the title, something about the kind of information you'll find in it. There are five standard types of documents; a definition of each is given on the following pages. Many users find most of the information they need in the first two types (guide and reference manual).

guide

A guide contains both conceptual and procedural information; it tells when and why to do something, as well as how to do it. A guide is usually the best introductory text (often including tutorials), yet it is organized so that experienced users can easily skip to the information they need.

Introduction

reference manual

A reference manual contains complete descriptions (traditionally known as "manual pages") of commands, utilities, system calls, library functions, or system file formats. The assumption in a reference manual is that you already know when and why a task should be done, so it concentrates on telling you what to do. Although these descriptions are complete, the authors have tried to keep them to one page; as a result they sometimes are cryptic. Once you've become familiar with a product, a reference manual is an efficient source of information.

release notes

A release notes describe what has changed in a new release, and known software problems that users should be aware of, and, if available, ways to get around them. It may also contain page replacements for other documents.

manual

A manual describes the hardware that can be used with a UNIX System V/386, including instructions for installing and operating it. It is complete, detailed, and is usually written for experienced computer users. (A manual is to hardware what a reference manual is to software.)

product overview/roadmap

The product overview part summarizes the standard and optional features of a software product including AT&T product add-ons that may be purchased separately. It highlights aspects of the product that have changed since earlier releases, or that are different from similar products of other vendors. It gives prospective buyers or information systems managers a broad perspective of a system and how it might benefit them.

The roadmap part helps identify which documents are needed to do particular tasks. It describes how a product's documentation is organized, and gives a description of each document.

Conventions for Document Titles

To make them shorter and easier to read, document titles in this book do not show "AT&T" or "UNIX System V/386" even though the official document title does include those words.

For example, the full title is:

UNIX System V/386 Release 3.2

Programmer's Reference Manual

In this document, the shorter or abbreviated title is

Programmer's Reference Manual

Aids for Identifying Documents




Figure 5-1: The Big Picture: Categories of Tasks

Figure 5-1 shows six major categories of computer-related topics: Obtaining Background Information, General Use, Administration, Programming, Networking, and Enhancing the System (for those with UNIX System source licenses).




Figure 5-2: Obtaining Background Information

Figures 5-2 through 5-7 show how the documents that discuss these topics are related. Boxes enclose single document titles and related groups of documents. Overlapping boxes show documents that should be used together. Arrows show the order in which documents usually should be read and point to other major categories you might want to examine.

The Alphabetical Index lists topics associated with each of the six major categories. You can look up a topic in the first column and follow that entry across the page to determine the documents that discuss it. The last column tells where you can find a description of the document in Chapter 6.

There are several ways you might use the figures in this chapter. Two possible scenarios are described below.

First scenario: You want to find out how to send mail electronically. Look in the Alphabetical Index for the word "mail." It is among the entries in the Topic column, and lists the *User's/System Administrator's Reference Manual* as a document that explains how to send mail. If you have a copy, you can look up this information. If you don't have one, you can read the description in Chapter 6, and decide whether or not to order it.




Figure 5-3: General Use

Second scenario: You want to help an inexperienced programmer learn about the UNIX System. Of the categories in Figure 5-1, General Use and Programming seem the most relevant. Turning to Figure 5-3, a more detailed look at the General Use category, examine the box labeled "User Documents." It lists the two related documents that new users should read and indicates the order in which they should be read. By looking at Figure 5-3 in this way, you can identify which documents the programmer needs. Figure 5-3 also points to other categories a general user might want to examine (Programming and Networking). Follow the same procedure for the Programming category. For all documents that you identify as possibilities, you can read the descriptions in Chapter 6.




Figure 5-4: Administration




Figure 5-5: Programming




Figure 5-6: Networking




Figure 5-7: Enhancing the System

The SVVS tests can be invoked through a test driver. A report generator formats and prints test results. The test driver and report generator are controlled by a user-friendly front end.
